Tender for Road, Sidewalk, and Drainage Improvements at Various Locations in the Village of Newbury

Tenders, sealed in an envelope which shall be clearly marked as to contents and addressed to the Clerk, will be received by the **Village of Newbury, 22910 Hagerty Road, Newbury, Ontario, N0L 1Z0**, until **2:00 p.m.** local time, as recorded by the Village of Newbury on the date and at the place of tender, on

Thursday, March 28, 2019

for the construction of the works described below.

On the same day, commencing at 2:05 p.m. local time, the tenders will be opened and read publicly by the Village of Newbury, at the above-mentioned address.

The work consists generally of the supplying of materials, labour, and equipment for Road, Sidewalk, and Drainage improvements at various locations including:

• Remove existing sidewalk	-	2,310	m ²
• Install new AODA compliant sidewalk	-	4,950	m ²
• Road base repair	-	1,100	m ²
• Pulverize existing asphalt	-	6,300	m ²
• Road excavation	-	5,000	m ²
• Granular 'B'	-	2,600	Tonne
• Granular 'A'	-	2,760	Tonne
• HL8 Base Asphalt	-	625	Tonne
• HL4 Base and Surface	-	920	Tonne
• HL3 Surface Asphalt	-	740	Tonne
• Demolish and remove existing concrete culvert	-	1.0	L.S.
• Supply and Install new CSP Arch Culvert	-	1.0	L.S.

Each tender must be accompanied by a tender deposit in the form of a certified cheque or bid bond in the amount of **\$90,000.00**, made payable to the Village of Newbury.

Tenders are subject to a formal contract being prepared and executed.

The Tenderer agrees that the Village has the right, at its own discretion, to accept or reject any non-compliant tenders without stating the reasons therefore and that the lowest or any tender will not necessarily be accepted.

The Tenderer understands that fundamental to this competition is the selection of a tender that, in the Village's opinion, is in the best interest of the Village. To this end, the Tenderer agrees that the Village reserves the right to select a winning tender that may be non-compliant.
