- 1. The TSSA variance application has been sent in. TSSA technician notified Scott Tupholme of Poleair that prior to any variance being given, the damper had to be in working order. Alberts Generator was in and replaced the motor. Scott was asked to come back and inspect the dampers.
- 2. An electrician must install the personal gas monitor and once this is done Ken Mitchell from Hetek will come back and set up the commissioning of the system.

Mike advised Council that he will have the hydro done next Tues. or Wed.

- 3. Flowmetrix has replaced the meter at the sewer plant.
- 4. Chatham-Kent were called out to inspect the FCHS grinder pump as the alarm had been activated. It was noted that a large wipe was caught in the impeller. It was cleaned and put back into service. With permission from Council the cost of the call out will be invoiced to FCHS.
