#### **7.1** Fire

Fire Chief Chad Trethewey attended the meeting at 7:00 pm.

i) Training Update

There is no training report for December. Two firefighters are starting fire school (as required by the regulation) in January through the Elgin-Middlesex Regional Fire School.

ii) Firefighter Recruitment

There are three new firefighter recruits starting tonight (two in firefighter capacity and one junior firefighter). The probation period is six months.

# iii) Firehall Overhead Door Replacement Update

The Reeve and Clerk-Treasurer met with Project Manager from Spriets. A final list of deficiencies was forwarded to Agri-Urban Buildings Inc. Chief Trethewey confirmed that the round hole in the drywall was from vent removal a few years ago. He will forward pictures of the holes in the beams to the Clerk for submission. Reeve Brewer advised that Council will hire a cleaning service to clean once the office is cleared of garbage.

### iv) Furnace Quote (cc - Council)

Chief Trethewey advised that the furnace has kept working since a new gas valve and thermostat were installed. The furnace is approximately 30 years old. The Clerk-Treasurer will investigate any grant programs available for replacing furnace.

#### v) Other:

Chief Trethewey advised that he has found dead bird carcasses and noticed daylight coming in at the end of the metal work and that the roof is leaking. He contacted McNaughton's to see if there is any warranty remaining from the roof replacement.

The Chief was advised to obtain a price on rigid hose for use at fire calls where this is no accessible hydrant.

Fire Chief Trethewey left the meeting at 7:40 pm.
