(b) <u>WATER:</u>

- 1. June water reads. There were two issues one homeowner's meter had no reading when there should have been and another had built a deck over the outside read. Both were notified.
- 2. SWM water agreement review. Council reviewed the draft agreement and had some issues with a couple of paragraphs. Council agrees that the Village of Newbury has something to offer SWM as a benefit to their system and that this benefit should result in lower water rate the same as Chatham-Kent.
