CALL TO ORDER

1. FCM Municipal Asset Management Program – Funding Agreement

The agreement is for the Middlesex Municipal Joint Road Assessment Program which Newbury participated jointly with the County and the other Middlesex municipalities. This is the Asset Management Program created by Streetscan in 2021. The Village has spent \$5,619.49 with the maximum grant available is \$6,185.50.
