The purpose of the consent application is to sever land from the subject property (Concession 2 Pt Lot 17) for the creation of one (1) parcel for future development. The severed parcel is irregular in shape and will be approximately 1.4 ha (3.49 ac) in size with a frontage of 33.5 m (110 ft.) on Hagerty Road and 340.6 m (1,117.5 ft.) on Wellington Street. The depth of the severed parcel will be approximately 39.6 m (130 ft.) measured from Wellington Street. The retained lands will remain irregular in area over the span of the railway corridor and will retain frontage on Hagerty and Dogwood Road (Southwest Middlesex).

Planner Marion Cabral attended this portion of the meeting. Melanie Postel, Russ and Sue Rabideau, Jim and Carol Sandford, Shawn and Tammy Cartlidge, and Peter Steele were present. The Canadian National Railway Company was represented by Andrea Paterson and Leighton Zink, Denton's Canada LLP.

Ms. Paterson spoke to the consent application; outlining CN's plans to divest of various pieces of property that have been deemed surplus to their needs. Paterson requested that several of the conditions proposed as part of the consent be reconsidered as CN is not proposing to develop the severed parcel or be an entity using that land in future. She stated that fulfilling all conditions may be problematic for CN to resolve.

Planner Marion Cabral reviewed the Staff Planning Report for Consent Application B01-2022 which supported the severance of a single lot with conditions. The proposed conditions were reviewed on an individual basis.

Members of the public raised concerns on the intended use of the severed parcel, the effects on the established residential area, why CN is proceeding at this point in time, loss of green space. Planner Cabral confirmed that the current zoning of the land is commercial from Hagerty Road to about Broadway Street and residential from Broadway west.

"Whereas, Wednesday, June 8, 2022, is the 30<sup>th</sup> annual World Ocean's Day. World Oceans Day is the United Nations day for celebrating the role of the ocean in everyday life and inspiring action to protect it;

Whereas, countries around the world, including Canada as a prominent leader, have committed to protecting 30% of their ocean territory by 2030 in order to reverse nature loss in the ocean and safeguard at-risk marine life;

Whereas, the ocean is home to hundreds of species at risk, vulnerable ecosystems, and is a crucial carbon sink shielding us from the worst of climate change;

Whereas, the ocean produces over half of the world's oxygen and absorbs 50 times more carbon dioxide than our atmosphere, therefore protecting the ocean is in the interest of all life on Earth, and communities both coastal and inland, as it is essential to our shared future;

Whereas, it is the jurisdiction of the Government of Canada, under various pieces of legislation and regulation, to establish marine protected areas in consultation with Indigenous Peoples. Many Indigenous nations and communities are leading in the conservation of the ocean, and have been stewards of the ocean since time immemorial;

Whereas, it is important for municipal leaders to demonstrate support for actions to safeguard the ocean, as they have for action on climate change and other environmental matters of national importance;

Whereas, in celebrating the ocean, and protecting its habitats and ecosystems, we can together raise the profile of ocean conservation's critical role in improving planetary health and slowing the crisis of species collapse and ecosystem decline;

Therefore be it resolved that the Village of Newbury recognizes the 30<sup>th</sup> anniversary of World Oceans Day on June 8, 2022 and supports national and international efforts to protect 30% of the ocean by 2030." – Carried.
