Planner Marion Cabral was in attendance. Matt Campbell from Zelinka Priamo attended the meeting, as well as property owner Theresa Rankin.



Planner Cabral reviewed the Planning Staff Report on Zoning By-law Amendment ZBA 04-2023 and Plan of Subdivision 39T-NEW2301 recommending approval of the Zoning By-law Amendment. Clerk-Treasurer Cathy Case advised that the notice was circulated as per the requirements of the Planning Act and posted on site.

Matt Campbell, agent for both the owner and developer, gave an overview of the proposal for the 17-lot subdivision. The land is designed by the Village for development and the zoning amendment addresses contemporary standards for lot sizes and removes a portion inaccurately designated as open space.

The public in attendance were given the opportunity to comment on ZBA04-2023. Those in attendance brought forward concerns related to the affect on the community and municipal services, costs, flooding in the area and drainage concerns. Planner Cabral advised that the zoning amendment is only one part of the process. The developer will be required to obtain subdivision approval from the County of Middlesex and enter into a subdivision agreement with the Village.

Reeve Brewer explained that there is a process under the Drainage Act to have municipal drains investigated.

Councillor Derbyshire commented that any subdivision would create more traffic and more people.

Cabral advised that a jurisdictional scan across Ontario was reviewed. The Clerk-Treasurer advised that notice of the meeting was circulated as per Planning Act requirements.

Reeve Brewer commented that approval of the Official Plan and Zoning By-law amendments would be the first step in the process. Council will be looking at implementing a policy to oversee the keeping of chickens which would include inspections and other conditions.
