CALL TO ORDER

Reeve Brewer called the meeting to order at 6:00 pm.

1. DECLARATION OF PECUNIARY INTEREST:

"That Council convene as the Committee of Adjustment for the purpose of consideration of Consent Application B01-2022 from the Canadian National Railway Company at 6:01 pm." – Carried.

The purpose of the consent application is to sever land from the subject property (Concession 2 Pt Lot 17) for the creation of one (1) parcel for future development. The severed parcel is irregular in shape and will be approximately 1.4 ha (3.49 ac) in size with a frontage of 33.5 m (110 ft.) on Hagerty Road and 340.6 m (1,117.5 ft.) on Wellington Street. The depth of the severed parcel will be approximately 39.6 m (130 ft.) measured from Wellington Street. The retained lands will remain irregular in area over

the span of the railway corridor and will retain frontage on Hagerty and Dogwood Road (Southwest Middlesex). The Committee of Adjustment had deferred decision on the application at the May 9, 2022 meeting.

Planner Marion Cabral attended this portion of the meeting. Shawn and Tammy were present. The Canadian National Railway Company was represented by Andrea Paterson, Denton's Canada LLP.

Ms. Paterson requested that the Committee of Adjustment reconsider imposition of conditions related to the requirement to provide municipal servicing, as well as the requirement to provide payment-in-lieu of parkland.

Planner Marion Cabral reviewed an updated Staff Planning Report for Consent Application B01-2022 and discussed the conditions. Those persons from the public in attendance were provided opportunity to address the Committee.

"THAT the Consent Application B01-2022 filed by Denton's Canada LLP on behalf of the Canadian National Railway Company, in order to sever one (1) lot with a frontage of approximately 33.5 m (110 ft) along Hagerty Road and lot area of approximately 1.4 ha (3.49 ac) from an existing 9.85 ha (24.34 ac) parcel legally described as Concession 2 Part Lot 17, Village of Newbury, be GRANTED subject to conditions;

FURTHER THAT Consent B01-2022 be subject to the following conditions:

- That the Certificate of Consent under Section 53(42) of the *Planning Act* shall be given within two years of the date of the notice of the decision. The request for the Certificate of Consent shall be accompanied by a written submission that details how each of the conditions of severance has been fulfilled.
- 2. That any outstanding property taxes be paid in full.
- That a draft reference plan be prepared by an Ontario Land Surveyor for the purposes of facilitating the transaction of Consent B01-2022 and that this plan be approved by the Village prior to being deposited with the Land Registry Office.
- 4. That the applicant submits an Acknowledgement and Direction duly signed by the applicant.
- That the Owners' solicitor provide a Transfer in Preparation to the Village, together with a deposited reference plan and a Schedule describing the land to be transferred, for the purposes of the issuance of a Certificate of Consent.

- That the Owner dedicate lands up to 13 m (42.7 ft) from the centerline of construction of County Road 1 (Hagerty Road) across the severed lot to the County of Middlesex for the purposes of road widening if the right-of-way is not already to that width.
- 7. That, if deemed necessary, the Owner dedicate lands along the Wellington Street frontage to the Village of Newbury for the purposes of road widening.
- 8. That the Owner submit an undertaking in a form satisfactory to the Secretary-Treasurer to register an electronic transfer of title consistent with the Acknowledgement and Direction and the decision of the Committee of Adjustment.
- 9. That one copy of the reference plan be submitted to the satisfaction of the Village.
- 10. That, if deemed necessary by the Village, an agreement be entered into with the Village (including terms as determined by the Village to be necessary) registered on title and binding on future owners, which addresses connections to municipal water supply and municipal sewer facilities. The cost of drafting and preparation of the foregoing Agreement shall be paid by the Owner.
- 11. That, if necessary, the fee for the Certificate of Consent be paid in accordance with the Village's Fees and Charges By-law.
- 12. That, if deemed necessary, a revised assessment schedule in accordance with the Drainage Act, as amended, be commissioned and paid for by the Owners.

As the proposed severance is generally supported by the policies of the Provincial Policy Statement, the County of Middlesex Official Plan, and the Village of Newbury Official Plan." – Carried.

The Secretary advised that Notice of the decision will be mailed within the prescribed time frame and that the Notice will include information on the appeal process.
