3. Update on Equipment

Fire Chief Trethewey advised that the magnetic switch for the siren will need replacing. It is a single phase magnetic starter. The last repairs were to the timer. Councillor Noe will have a look at what is required and make repairs as necessary. Pump tests are scheduled for this month. The foam line will be repaired at that time.

- 1. the Attorney General of Ontario to halt the proclamation of the Early Resolution reforms included in Bill 177, Stronger, Fairer Ontario Act.
- the Attorney General of Ontario to review the Early Resolution provisions of the Provincial Offences Act and take action to streamline and modernize this section with a view to making it easier for the public and prosecutors to engage in resolution discussions, and to administer early resolution proceedings in Provincial Offences Court. And
- the Attorney General of Ontario to enact changes to the Provincial Offences Act and any related regulations, to permit the prosecutor and defendant or legal representative to

agree, at any stage of a proceeding, to a resolution in writing for proceedings commenced under Part 1 of the Provincial Offences Act and to permit the Clerk of the Court to register the court outcome immediately upon receipt of the written agreement without requiring an appearance before a Justice of the Peace."

- 9.(a).1. Cement work and benches at park – waiting for cement contractor to arrange for work to be done and for price on benches.
- 9.(a).2. Veteran's Road Boulevard – proposal from Russ Patton for ditch remediation

Councillor Patton reiterated his pecuniary interest in this item.

Council discussed the plan to cut down the slope of the ditch and level area in order that regular grass cutting can take place. The trees will be removed for the duration of the remedial work and returned once completed. Armour stones will be donated and placed in spot. Additional costs will be for topsoil if required and hydro seeding.

- 9.(a).3. Police Services Board no update
- 9.(a).4. Input has been requested from our insurers regarding installation of basketball nets at the park, as well as clarification on the type of mulch that can be used.
- 9.(a).5. Ron Sharpe has provided a price of \$3,600.00 per tree for the trees located at southeast corner of Dundas and York and the southwest corner of Queen and York.

Council directed that the Clerk-Treasurer obtain an opinion on the condition of the trees and report back at the next meeting.

9.(a).6. Planning Fee – By-law 128-19 does not provide for a fee for site plan applications or subdivision/condominium applications nor for the recovery of costs from a developer. Staff recommends that Council consider setting a fee for these types of applications.

9.(b).1. Councillor Challis submitted a notice of motion on renaming Dundas Street for consideration.

9.(b).2. Non-Residential Water Connection at 22678 Hagerty Road. This request is a carry over from 2020.

"THAT the Council of the Village of Newbury approve the application from Ryan Laporte at 22678 Hagerty Road in the Municipality of Southwest Middlesex for connection to the Newbury Distribution System; that Mike Golding be approved as contractor for this project and that Connection not be undertaken until all paperwork and fees have been submitted to the satisfaction of the Village of Newbury."

9.(b).3. Flooding issues at various locations in the Village following the weekend rains were discussed.

Councillor Noe pointed out that private drainage systems are not under municipal jurisdiction. Ratepayers can petition under the Drainage Act to have an engineer review drainage concerns.

9.(b).4. Storm sewers were discussed.

The catch basin in front of 9 Durham Street is full of weeds, debris, grass etc. It was noted that it has been several years since catch basins had been cleaned out. Council agreed that it is best to have the drainage in the intersection of Dundas and York checked with camera before starting to dig up the intersection. Staff will investigate options for camera equipment to have a look at municipal drainage system as soon as possible.

9.(b).5, The Clerk-Treasurer confirmed that there have been no requests to purchase unopened road allowances.
