CALL TO ORDER

Reeve Diane Brewer called the meeting to order at 6:00 p.m.

1. DECLARATION OF PECUNIARY INTEREST:

Mike Noe declared a pecuniary interest in an invoice from CPE that was being added to the accounts.

2. <u>DELEGATIONS:</u>

(a) 6:00 Jenn Huff, Count Planner and Erica Ogden, Planner, SCRCA

Jenn and Erica provided an overview of how the Planning Act and the SCRCA work. They reviewed charts and handouts with Council and staff that showed and explained Newbury's Settlement Area and existing zoning and floodplains. Council thanked Jenn and Erica for their presentations.

(b) 7:00 Russ Patton regarding his water connection on Coltsfoot Drive. (cc. Council – purple)

Russ reviewed the quotes for installing a hydrant and stated that it was too expensive and that he didn't want to install one and that he would prefer installing a blow off. Russ said he checked with his insurance company and realized that the cost to install a hydrant versus his savings in insurance would take 27 years to re-coop his money.

The Clerk advised Russ and Council that she had asked Kelly Moore, Newbury's Water Operator his opinion and he said it should be a hydrant. Russ said that he hadn't asked his supplier yet for a price but was going to soon. The Clerk said that she received a quote from Corix in London for a Mueller hydrant. Russ said that he had \$3200 in his budget for a hydrant but Spriet have quoted close to \$5000 to have it installed. Council was willing to contribute \$1500 towards the hydrant.

Russ said that Chris from Spriet had concerns of stagnant water but then realized a family of 5 would use enough water to keep the water from becoming stagnant unless Russ was away on holidays and then it should be flushed.

Russ said he wanted to install the water line on July 28th. Council asked Russ to let them know the price he gets from his supplier for the hydrant and they will discuss it again.

(a) WATER:

1. SWM/Newbury water agreement. A letter was sent to SWM Council regarding Newbury's unanswered questions. (cc. Council – white)

(b) **SEWER:**

- 1. Dillon Consulting is working on amending Newbury's Certificate of Approval (new generator). (cc. Council white)
- 2. Three quotes (3) quotes were received for yearly maintenance on the new gas generator. (cc. Council green)
